CARCERAL REDLINING

White Supremacy is a Weapon of Mass Incarceration for Indigenous and Black Peoples in Canada



Although Canada's crime rates have been declining for the past 20 years, rates of incarceration for Indigenous and Black people have increased disproportionately.


Since 2010, incarceration of Indigenous peoples has increased by <u>43.4%</u>, whereas the non-Indigenous incarcerated population has declined by <u>13.7%</u> over the same period^{*}.

Indigenous and Black Population vs Federal Incarceration Stats



While making up 3% of the general Canadian population, **Black people** account for <u>10%</u> of the federal prison population.^{*}

Indigenous people represent approximately 5% of the Canadian population but account for <u>30.4%</u> of the federal prison population.^{**}

Similar disparities are evident in provincial jails. For example:




In Nova Scotia, Black people represent <u>2%</u> of the general population but account for <u>14%</u> of the jail population.*

GENERAL POPULATION 2% VS. PRISON POPULATION 14%




In Manitoba, Indigenous people represent <u>16%</u> of the general population, but account for <u>70%</u> of the jail population.**

'CARCERAL REDLINING':

The systemic ways in which incarceration practices are used as a tool for social control by the <u>redlining of racialized communities</u>. There are effectively red lines drawn around certain communities to be criminalized and targeted for incarceration.
